Question 1: Can you please provide the s/n of the Eaton UPS?

State's response: No change. The serial number of the College's Eaton UPS is: EK251CBC09

Question 2: You specify Eaton brand only batteries on your RFQ# 040124-206-88202-04/11/24 Eaton does not manufactur it's own batteries. They simply relabel a CSB battery. The CSB part # is HRL12540W/FR. Is the CSB battery (an authorized Eaton replacement battery) (identical to the relabeled battery) acceptable in this bid? All specifications are identical in every way. It is literally the same battery, minus the screen printed label.

State's Response: Change. CSB battery part number HRL12540W/FR is identified as the same battery model as Eaton battery part number PWHR12540W4FR and is an acceptable alternate. See modification to specification section below.

- Contractor shall remove 64 existing batteries from Eaton UPS Model 9390-100-160 and dispose in accordance with EPA Approved disposal requirements. Contractor shall remove all batteries in accordance with manufacturer specifications.
- Contractor shall install all new replacement batteries in Eaton UPS Model 9390-100-160 in accordance with manufacturer specifications.
