

## MILITARY SPOUSES AND DEPENDENTS

Get help paying for college.

Trident Technical College is an affordable education option for military spouses and their college-age children. If you are stationed in Charleston, TTC can offer you:

- Tri-county resident tuition rate discount
- S.C. Lottery-funded Tuition Assistance, which can pay \$75 per credit hour; at least six credit hours required
- Veterans services including the Post-9/11 GI Bill®, Chapter 35 and a veterans benefits counselor to assist you
- No-cost tuition for more than 100 programs through SCWINS (see <u>bit.ly/SCWINSatTTC</u> for more information and eligibility requirements)
- S.C. Veterans Affairs Tuition Waiver for dependent children under the age of 26. An application is available through the **my.tridenttech.edu** portal or in Trident Tech's Financial Aid/VA office.

## **MYCAA SCHOLARSHIP**

## **About the scholarship:**

The My Career Advancement Account Scholarship (MyCAA) is a workforce development program that provides up to \$4,000 in financial assistance to eligible military spouses. The scholarship assists military spouses in pursuing licenses, certifications or associate degrees necessary to gain employment. Spouses may use their MyCAA scholarship funds at any academic institution approved for participation in the scholarship.

## **Who qualifies:**

- Spouses of active-duty service members and spouses of National Guard and reserve service members on Title 10 orders in pay grades E-1 through E-9, W-1 through W-3 and O-1 through O-3.
- Spouses who have completed high school or obtained a GED.

**NOTE:** You can continue your approved education and training plan if your sponsor is promoted.

## **More information:**

The MyCAA Scholarship provides a maximum tuition benefit of \$4,000 with an annual fiscal year cap of \$2,000 to assist eligible military spouses who need professional credentials to meet their career goals.

- MyCAA will pay for tuition and testing fees.
- Recipients have a three-year time limit to use the MyCAA funding, which begins on the start date of the first course taken.

**NOTE:** Programs only leading to a certificate are not eligible for MyCAA. Recipients must be in pursuit of a recognized postsecondary credential.

## **SCWINS**

South Carolina residents enrolled in critical workforce programs that lead to an industry-recognized credential, certificate, diploma or degree are eligible for the South Carolina Workforce Industry Needs Scholarship (SCWINS).

# S.C. LOTTERY AND TUITION INFORMATION

**To receive S.C. Lottery-funded Tuition Assistance:** 

- **1.** Active-duty military/spouse permanently stationed in South Carolina must submit copy of orders to the Admissions office.
- **2.** Complete and submit a Free Application for Federal Student Aid (FAFSA) at studentaid.gov.

For Fall 2025, Spring 2026 or Summer 2026, submit the 2025-26 FAFSA.

3. Have a declared major.

For current tuition and fee amounts, visit www.tridenttech.edu. S.C. Lottery-funded Tuition Assistance is available to eligible students. For questions, contact the Financial Aid office at 843.574.6110.

If you are using MyCAA, apply online, or you may contact your Family Readiness Center for assistance. Once you have registered for courses for the upcoming semester, please use your Trident Tech email address to request your ETP from the Registrar's office at **records@tridenttech.edu**. (Allow at least three business days for the ETP to be completed once you have registered for classes.)
