Questions:

Question 1: Are you accepting rental / lease bids or strictly purchase?

State's Response: No change. This solicitation for TTC polos is strictly for purchasing. Rental/ lease bids will not be considered.

Question 2: What is the prior bid tabulation?

State's Response: No change. A prior bid tabulation does not exist. This is TTC's initial solicitation issued for these services.

Question 3: Does personalization need to be included in the price of the garments?

State's Response: No change. Yes, TTC will not pay any fees or charges not expressly listed and priced in the solicitation's Bidding Schedule. Please reference bidding instructions on page 33 of the solicitation.

Question 4: Does shipping need to be included in the price of the garments?

State's Response: No change. Yes shipping must be included in the price of the garments. Reference the answer to question 3.

Question 5: On page 17 #4 Logo Requirements: A one-time sample shall be submitted and approved prior to production (see Attachment 5 for logos). There are 2 logos on Attachment 4 and there is no Attachment 5.

State's Response: Change. TTC acknowledges that the reference to "Attachment 5" in Section #4 titled "Logo Requirements" on page 17 is incorrect and that no Attachment 5 exists in the solicitation. The correct logos are provided in Attachment 4.
