THE FOUNDATION MADE SCHOLARSHIP AWARDS TO 545 AND 476 STUDENTS, TOTALING \$512,766 AND \$466,717 IN THE YEARS ENDED JUNE 30, 2025 AND 2024, RESPECTIVELY. SCHOLARSHIPS HELP OFFSET THE COST OF TUITION, FEES, BOOKS, CHILDCARE, AND TRANSPORTATION FOR ELIGIBLE STUDENTS. THE SCHOLARSHIP FUNDS, SUPPORTED BY INDIVIDUALS, BUSINESSES, AND OTHER FOUNDATIONS, ARE COMPETITIVE AND BASED ON CRITERIA ESTABLISHED BY THE DONORS AND THE FOUNDATION.
