Question 1: I have a question about service times and dates. Is there a particular time/day of the week that it needs to be done or are we open to providing service any day of the week, including weekends?

State's Response: No change. There currently is no set service days or times. Service may be performed on weekend days. Schedule agreement will be negotiated upon contract award.

Question 2: Are state taxes withheld from payment at 2% of total invoice amount? If so, is this money reimbursed if we also pay the SC state taxes?
