JUSTIFICATION FOR SOLE SOURCE PROCUREMENT


The basis for this sole source determination and the reason no other vendor is suitable is: The College trains and prepares its students using industry-standard equipment and software necessary to their chosen field of study. The industry standard for digital editing is the Adobe suite of products. Therefore, the College uses the full suite of Adobe products for its classroom and online instruction including but not limited to film and visual arts programs, engineering programs, ReadySC, as well as by the College's Marketing and other departments of the college.

The College requires the Adobe suite of Adobe Pro Document Cloud (DC) products as Adobe is the only company that provides all of the products needed for training and preparing students to industry standards for digital editing.

Adobe is the only vendor that can provide the full suite of all products used by the college. The Adobe Enterprise Term License Agreement includes the Pro Document Cloud products and support and Adobe's flagship product, Adobe Acrobat Pro DC. The College has Adobe Acrobat Pro DC installed and in use on all College computers. Licenses for Adobe Acrobat are bundled, at deeply discounted prices, with the Adobe Enterprise Term License Agreement and cannot be segregated from the Agreement.

Adobe has established fulfillment agents which serve as intermediary entities for Adobe in the fulfillment of orders on behalf of Adobe and Trident Technical College at prices negotiated between Adobe and the College. As the fulfillment agents only serve as intermediary entities of Adobe and no additional or less value is created by the fulfillment agents for the College, the products are considered only available from Adobe. Dear Mr. Demore:

Under an Adobe Enterprise Term License Agreement, Adobe appoints a third party to serve as a fulfillment agent. The fulfillment agent is contractually obligated to quote and sell to the end user at the price agreed between the end user customer and Adobe. The fulfillment agent may not alter the pricing in any way. When Adobe uses a fulfillment partner to process payment and/or delivery on Adobe's behalf, the customer does not have the opportunity to negotiate pricing with the fulfillment agent.

To summarize, Adobe, as the supplier, specifies the end user pricing in its agreement with the fulfillment agent. Adobe's contract with the fulfillment agent permits no deviation or discounting from that pricing by the fulfillment agent. In addition, Adobe is the only entity that can negotiate the terms of the ETLA agreement between the end user customer and Adobe.
