Title: Forklift

Is hereby amended as follows:

Following are questions that were received and answers to those questions.

- **Q-1:** What is meant by "travel light"? Is that a blue light that shines down on the floor when moving forward?
- **A-1: States Response.** No **Change.** The travel light is a light on top that strobes/circles so the forklift will be seen traveling on the road.
- Q-2: Explain what you want here:4th leaver control valve lockout: Leaver control to move forks to variable widths

Are you requesting a fork positioner only? Do you need the 4th valve with hosing capped with quick disconnects?

Or do you want a side shifting fork positioner, which will use the 3rd and 4th valves?

A-2: States Response. No Change. The level control must allow us to be able to shift the forks from the controls, not manually. All capabilities shall be included on the forklift when delivered.
