Q-1: Item # 1, I believe the correct 4Imprint item # is 101326-1513. Please confirm?

A-1: States Response. Change. The correct item number is 101326-1513. Please replace item # 1 reference item # 101326-1516 with 101326-1513.

Q-2: Item # 4, The referenced bag appears to be a 4Imprint exclusive item, meaning it is only carried by 4Imprint. Is there another bag that isn't exclusive to a distributor that you all would consider purchasing?

A-2: States Response. No Change. See page 15, Section III. Bidding Instructions and page 16, Item # 4 Crossland Journey 15' Laptop Backpack specifications.

Q-3: Item # 5, There is more than one red blanket for this item. Do you have a preference on which of the patterns you would prefer?

A-3: States Response. No Change. The Roll-Up Picnic Blanket is not restrictive to the inside pattern, as long as the Roll-Up Picnic Blanket meets the specifications listed on page 16, Item # 5.
