Revolutionizing Electric Vehicle Education (REVVED) is a collaboration between Trident Technical College, Spartanburg Community College, Greenville Technical College, and Clemson University. This faculty-driven consortium, with institutional leadership support, NSF projects/centers, and industry partners, will address the workforce needs of the Electric Vehicle (EV) manufacturing and service industry. The project’s primary research goal is to yield a deeper understanding of the processes required to create hybrid learning environments for upskilling workers and educating two-year college students in EV manufacturing and service.

The purpose of this solicitation is to purchase an electric vehicle as a training aid for the REEVED project’s faculty and students. The vehicle must be functional to allow for troubleshooting and diagnostics, which provides a higher level of knowledge for our students. Lastly, the vehicle(s) are needed for curriculum design, development, and implementation within the life cycle of the project.
