Q-1: Can you please confirm if 1" table top for lot item 2 would be good or you strictly go by 1-1/2" with regards to the solicitation.

A-1: 1" stainless steel table top will work as long as the following are met:

- Stainless steel over 1" plywood core, wrapped on the edges with stainless steel.
- Supporting structure base cabinets (drawers and double doors) provide enough support to the table such that the top does not experience deflection with a part weighing up to 100 lbs. is placed in the middle of the table.

Q-2: Can you please specify manufacturer of choice or alternate would do?
