Title: Waste Containers for TTC

Is hereby amended as follows:

This amendment is issued to answer questions received.

Q-1: Please see questions below. Rubbermaid is an item preferred by many, and will allow ease of order per the minimum order quantity to avoid over stock.

For item 1: Rubbermaid part # FG295073BLA Deskside side bin

For item 2: Rubbermaid part # FG9W0000BLA Landmark Series Gas Station / Store Front Container

Please let me know if this is an acceptable option.

A-1: No. Neither item suggested meet the required specifications. Item 1 as suggested has a capacity of 1 gallon and does not have a lid. Nor will it fit all of the recycle bins currently in use at TTC. Item 2 as suggested has a 35 gallon capacity and TTC wants a 42 gallon capacity container to maximize the efficiency of the waste management program. In high volume areas a 35 gallon container would fill up much more quickly than a 42 gallon container and require more frequent servicing.
