On page 17, section III. Scope of Work/Specifications,

Delete the following: **Minimum Warranty: One year**

Replace with: **Minimum: Limited Manufacturer's One Year Warranty**

Changes Related to Questions:

Q1. Will the CMM equipment have access to an air supply?

A1: Should the CMM need compressed air, there is access to a compressed air manifold with a rated discharge pressure of 125 PSI and free air delivery rate of 691 CFM. The vendor should include any equipment needed to condition this air source to that needed by their machine. This includes, but may not be limited to, pressure regulation, filtering, drying, and cooling.

Q2. Lot 1 specifies "CMM system frame, as necessary, for use on shop floor", what if our equipment does not have a frame?

A2: The CMM should include a standard parts fixture for securing and orienting parts on the machine's table.
