Is hereby amended as follows:

This amendment is issued to answer questions received and make changes to the specifications. Specification changes will be made as follows: Removals are shown by striking through and insertions / additions are highlighted in yellow.

Part A: Questions

Following are questions that were received and answers to those questions.

Q-1: Is there a deadline for receiving the saw and if so, what is the date?

A-1: States Response. No Change. There is no set deadline for receiving the saw. TTC would like to receive it as soon as available.

Q-2: Looking at the floor layout it looks like the saw is going in a small room with a double door. What are the dimensions of the double door and can a forklift enter the room?

A-2: States Response. No Change. The saw is going into a caged area with no ceiling. The door dimensions are 99" wide x 98" tall. The saw only needs to make it through the large roll up door at the back of the building within reach of our overhead crane. Our staff will crane it into place.

Part B: Changes to Specifications

Page 15, Section III. Scope of Work/Specifications, add the following:

START-UP: Upon request by TTC, contractor shall perform start-up of equipment, to include the following:

- The Contractor shall check equipment level.
- The Contractor shall add coolant.
- The Contractor shall check the blade installation to verify correct.

TRAINING: Upon request by TTC, contractor shall demonstrate equipment at a mutually agreed upon time.
