Is hereby amended as follows:

**Changes not related to questions:**

There are no changes not related to questions.

**Questions:**

**Q-1:** Do you want a radius added to the corners of the countertop?

**A-1:** State's response. Change. Yes. Contractor shall add a (1) one inch radius to the corners of the large central countertop.

**Q-2:** How thick do you want the countertops to be?

**A-2:** State's response. Change: The countertops will be (3) three cm thick.

**Q-3:** Can you tell me how many square feet the countertops comprise?

**A-3:** State's response. No change. From page 13, Section III, Item 1: Contractor shall perform their own filed measurements.

**Q-4:** Other than the large central countertop, are there any other countertops included in this job?

**A-4:** State's response. Change: Other than the large central countertop the job also includes the prep table and sink located to the rear and side of the central countertop.

**Q-5:** Will there be new stove-tops and sink installed in the new countertops and who will install them?

**A-5:** State's response. No change. There will be no new stove-tops. TTC will remove the existing stove-tops and sink prior to replacement of the countertops and will re-install the same stove-tops and sink upon completion of the countertop installations.

**Q-6:** Will a seam be allowed on the large central countertop?

**A-6:** State's response. No change. A seam will be allowed on the large central countertop if needed.
