Q-2: Are the casters rigid or swivel type, and do all (4) need to be lockable?

A-2: Caster shall be swivel type with (1) locking caster.

Q-3: What do the Teflon inserts look like?

A-3: TTC cannot provide a description. The Teflon insert is to protect the aircraft parts from damaging themselves or the box structure. The insert can be another chemical resistant material. In Detail A the 1" Ø and 2 "Ø holes should include the insert.

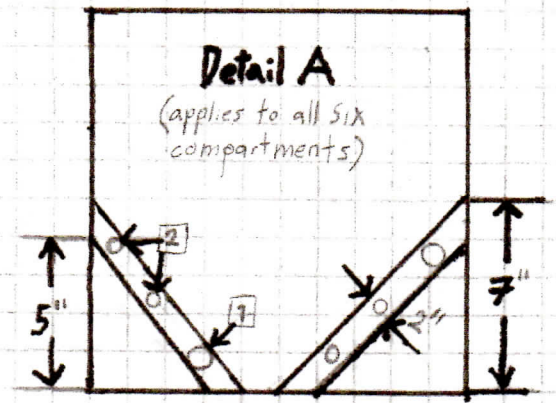
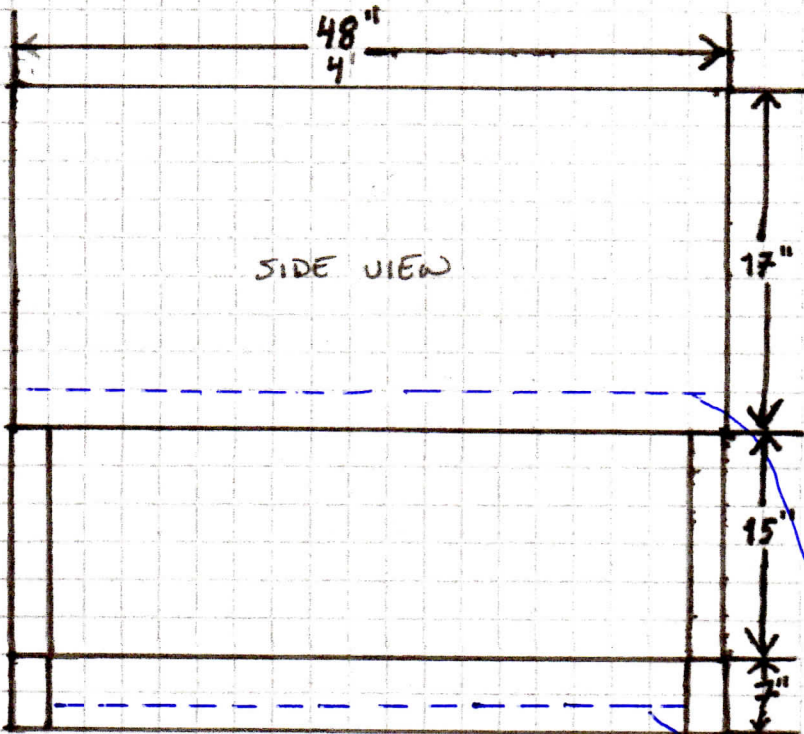
Q-4: Are the angles welded flush to the top surface of Detail A?

A-4: The angles shall be welded 2 inches from the top surface.

Changes related to questions received:

Q-5: A frame will be needed to support the top box and bottom shelf. Is the 17" and the 7" dimension inside or outside of the box?

A-5: A frame will be needed. The 17" is a depth measurement from the top surface of the box. (inside or outside would not affect the measurement). The 7" is also a depth measurement for the bottom tray of the box. See attached revised drawing for reference only. Offerors shall submit a shop drawing with their submittal

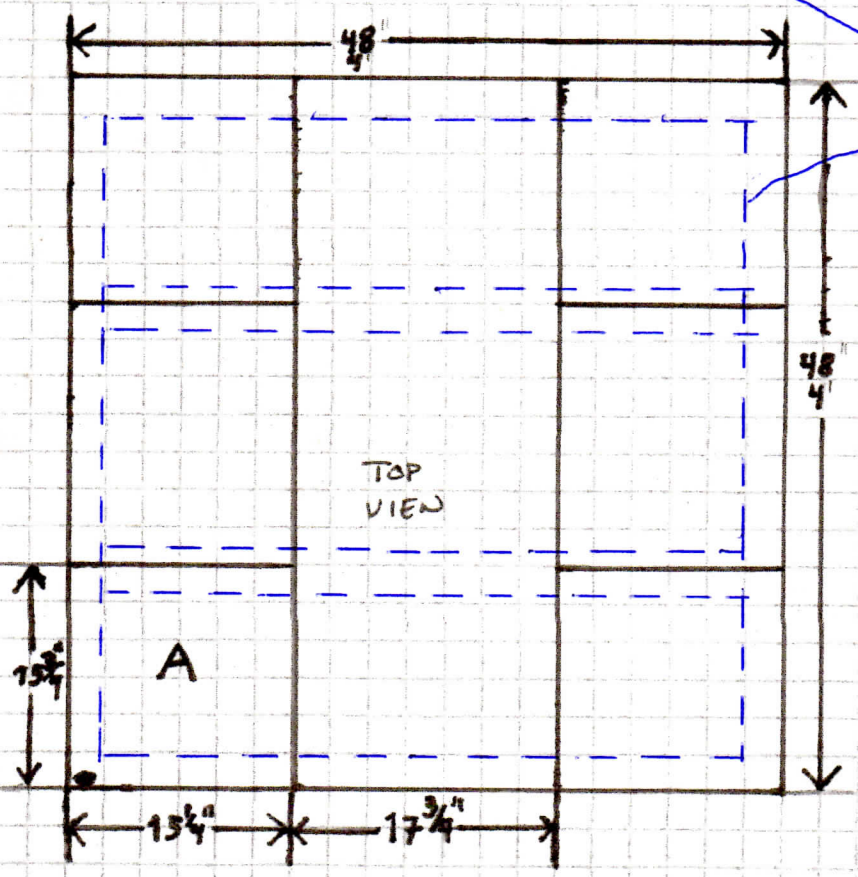
