Q-1: What is the college currently paying for treatment?

A-1: No change. The college is currently paying \$4,800.00 annually.

Q-2: You requested we quote 5 pumps for your condensers. I understand that you will need 2 pumps for inhibitors and 2 for oxidizing biocides; what is the additional pump for?
