- Q-1: Services will be provided the first full week of each month, are these Mon-Sat and are the times specific?
- A-1: **States Response**: No Change. TTC requests that all pond services be performed Monday Friday during the hours of 7:00 am 5:00 pm.
- Q-2: Do you have the previous pond treatment information?
- A-2: **States Response**: No Change. Prior treatment of the Thornley Campus ponds consisted of being treated for various algae, pond weeds (emergent and submergent) and weeds along the edges of the ponds.
- Q-3: What type of algae have you dealt with in the past?
- A-3: **States Response**: No Change. Please see answer #2 for the types of algae TTC has dealt with.
- Q-4: Are the ponds stocked or have been stocked with fish?

- A-4: **States Response**: No Change. The Thornley Campus ponds have only been stocked with grass carp and no other type of fish.
- Q-5: Have pond dyes been a part of the program in the past?
- A-5: **States Response**: No Change. The only dyes allowed in the Thornley Campus ponds is black dye.
- Q-6: Do you have access to the pond depths of each pond?
- A-6: **States Response**: No Change. The depths of each of the Thornley Campus ponds are all less than 10 feet.
- Q-7: Is the overgrown vegetation on pond #4 desirable?
- A-7: **States Response**: No Change. The overgrown vegetation on pond #4 are plants that have been installed by the horticulture program.
